" Presiding Officer- Out of existing 14 Commercial Courts, only 01 Commercial Court at Sriganganagar is lying vacant, for which additional charge has been given to District Judge, Sriganganagar.

Staff- Total 151 Posts are sanction in which 87 are filled and 64 are vacant, so 58% posts of staff are filled. Regarding the vacant posts concerned District Judge have been directed to ensure that at least 90% of the vacancies of supporting staff in commercial court(s) be filled up. "


